Mayor Demings convened the Orange County Citizens Safety Task Force on November 6, 2020

Seven shootings in three-weeks that involved two fatalities

Goal: Identify solutions and strategies to prevent and reduce gun violence and violent crime in the community

Objectives:

- Review state and local data on gun violence and violent crimes
- Examine youth and young adult risk and protective factors
- Research evidence-based programs and best practices
- Review existing programs and services in the community
- Review intervention strategies that deter the possession, carrying and use of illegal firearms
- Identify strategies that will mobilize the community and enhance engagement
- Expand prosecution of gun violence and violent crimes



Four Pillars

- Prevention: Work with youth ages 13 25 in zip codes where the incidence of violent crime is highest
- Intervention: Promote interagency cooperation and coordination among service providers in Orange County to assist with reducing gun violence and violent crimes pertaining to youth
- Enforcement: Review data & evidence-based enforcement strategies to reduce gun violence
- Prosecution: Enhance prosecution of gun violence and violent crimes

Community Crime Survey



Community Crime Survey – Key Findings

Community Crime Survey – 2,188 Responses | 43 Zip Codes

- 84% rated their feeling of safety as safe or very safe
- 9% someone in their household had been the victim of violent crime, and

6% reported the crime

 28% - stated the level of gun violence and violent the past three years has increased

- 64% of the respondents rated the level of police excellent or good
- 33% felt law enforcement makes it easy to input to them to help solve problems
- 45% did not feel they had access to prevention and intervention programs
- 65% expand mentoring and intervention programs for youth and young adults



Prevention Subcommittee



Recommendation #1: Use a Racial Equity Lens and Trauma-Informed Approach to Implement All Task Force Recommendations

- Examine racial impacts in the implementation of recommendations
- Consult with racial equity practitioner
- Incorporate ongoing trauma-informed training at all levels of implementation
- Screen all participants for trauma and symptoms



Recommendation #2: Expand/Enhance Access To Effective Youth, And Parenting, Mental and Behavioral Health Programs

- A. Allocate funding to programs operated by "Credible Messengers"
 - Programs that offer youth mentorship, conflict resolution, life skills and job training
- B. Allocate funding to implement research-based models proven to prevent violent crime
- C. Invest in an effective system of behavioral and mental/trauma-informed services for at-promise youth
- D. Develop/implement a system that provides free transportation to programs for youth



- E. Implement changes to the Citizens' Review Panel (CRP) Advisory Board for Human Services
 - Publicize the opportunity to serve
 - Include youth participation
 - Add violence prevention to focus areas
- F. Invest in programs that teach life skills to parents and youth





Recommendation #3: Transform the Criminal Justice System to Reduce Disproportionate Arrests and Incarceration of Black Youth

- A. Develop and implement strategies to eliminate over-policing and develop/implement solutions to reduce arrests for low level offenses
- B. Review all other stages of the criminal justice system after arrests are made and reform them to reduce criminalization of at-promise youth
 - Eliminate cash bail for County level offenses (referred to the Orange County Public Safety Coordinating Council)



Recommendation #4: Support Economic Development, Reduce Poverty and Address Family Economic Insecurity

- A. Develop policies/programs that encourage businesses to offer internships, apprenticeships, mentorships and alternatives to recidivism for youth
- B. Develop and implement comprehensive policies/programs to help families build generational wealth and overcome poverty
- C. Offer financial planning and mentorship services to residents



Recommendation #4: Support Economic Development, Reduce Poverty and Address Family Economic Insecurity (continued)

- D. Continue to support the HOUSING FOR ALL 10-Year Action Plan
- E. Invest in Black-owned business development





Recommendation #5: Reduce Access to Illegal Firearms

- A. Conduct a comprehensive review of State and Federal laws governing the sale, purchase, ownership, and carry of guns
- B. Collaborate with/support citizen groups advocating for common sense gun legislation at the State level

Recommendation #6: Improve Overall Neighborhood Conditions

A. Invest in improvements in the target zip codes via the County's Neighborhood Services Division



Recommendation #7: Communicate Key Issues and Programs to the Community

- A. Implement targeted strategies to communicate and obtain input from residents on violent crime and prevention programs
- B. Respond to the root causes of violent crime and broadly communicate effective resources and youth programs
- C. Develop and disseminate social media campaign aimed at strengthening anti-violence social norms



Intervention Subcommittee



Recommendation #1: Develop a detailed plan that addresses generations of neglect and poverty by formulating a 10-year vision with a systemic focus that reviews the structural changes that provides a healthy community where everyone thrives

Recommendation #2: Increase the use of grassroots organizations in the community and allocate funding for them

- Fund community specific programs with credibility
- Provide training and technical assistance to apply and maintain funding



Recommendation #3: Develop a Neighborhood Accountability Board and increase the use of diversion services

Increase the use of civil citation and other diversion services

Recommendation #4: Define, develop, and fund a credible messenger's program

- Develop credible messenger's program from the current operating model
- Enhance the program model to include non-traditional arts



Recommendation #5: Coordinate with mental health providers to increase the number of providers in the areas identified and require the agencies to increase their hours of operation

- Teach and educate families and youth life skills
- Develop on-line resource directory of prevention programs
- Collaborate with agency providers to develop recruitment video to retain and develop agencies

Recommendation #6: Provide safe and reliable areas for youth to congregate

- Create programs in community centers that attract youth
- Create additional mentorship programs
- Provide employability and life skills training



Recommendation #7: Create a realistic channel for communication with the community and the youth

- Create social media platform that reaches youth & families
- Create a user-friendly website providing community resources





Enforcement Subcommittee



Recommendation #1: Establish and maintain quarterly scheduled community public safety forums between law enforcement and community stakeholders over the next 12 months to review relevant data, solicit community input, and discuss and develop strategies to reduce gun/violent crimes

- Law enforcement agencies identify members to patriciate
- Engage community stakeholders to coordinate and participate in the forums
- Contract with community ambassador/groups to facilitate public safety forums



Recommendation #2: Increase the community's and law enforcement's use of evidence-based practices and non-traditional approaches of community policing and engagement to further build public trust in communities historically distrustful of law enforcement and that are disproportionately impacted by gun/violent crimes

- Law enforcement agencies continue to review and enhance community policing strategies
- Law enforcement agencies continue to educate and engage community stakeholders



Recommendation #3: Implement public safety workshops with law enforcement agencies and community stakeholders through an independent third-party facilitator

- Community ambassadors will work with community stakeholders
 & law enforcement to coordinate public safety workshops
- Contract with a third-party facilitator to conduct public safety workshops



Recommendation #4: Increase community awareness of Orange County Sheriff's Office Behavioral Response Unit and Orlando Police Department's Community Response Team mental health programs that provide a joint response to calls that involve mental health crisis

- Law enforcement will implement and maintain research study to evaluate effectiveness
- Law enforcement will initiate communication with community stakeholders to review and provide feedback
