#### Welcome and Introductions:

Allan Keen, Co-Chair began the meeting with a welcome address followed by Terry Prather, Co-Chair. The Chairs discussed the important work that the Task Force will embark to address the affordable housing crisis in our community. The Task Force members were asked to provide a brief introduction. Allan Keen reviewed the materials in the binder and the Task Force calendar. Terry Prather, Co-Chair introduced Orange County Mayor Jerry L. Demings for opening remarks.

#### Mayor Demings – Opening Remarks:

Mayor Demings thanked the co-chairs for taking on the responsibility of chairing the task force and the subcommittee chairs who will be meeting frequently over the course of the task force. Mayor Demings talked about "What's at stake, "a shortage of affordable and available rental homes for individuals and families, especially, low-income housing. Households are spending more than 30% of income on housing which is a cost burden. Mayor Demings mentioned Seattle's median housing costs is \$850,000. The goal of the Housing for All task force is to promote a transparent system that encourages community engagement and provides practical and lasting solutions for the affordable housing crisis in Orange County. As discussed in the Regional Affordable Housing Initiative Report, we need to encourage diversity of housing types and energy-efficient housing; preserve existing affordable housing stock; promote social and economic integration; and improve financial literacy.

#### **Public Comment:**

Citizen asked the Task Force to look at accessory dwelling units. He talked about ADU's as a
great resource for current homeowners; Denver and Los Angeles have put programs in place
with Habitat for Humanity. The citizen suggested looking into a program that provides new
housing stock without having to rely on developers and to look at small scale incremental
solutions.

#### Sunshine Law and Public Records Orientation – Kat Latorre, Orange County Attorney's Office

• Kat Latorre provided the Task Force members with a presentation on Florida's Sunshine Law and Public Records. The presentation included sunshine law meeting requirements; meetings must be open to the public and record of meeting minutes. The Public Record Law section reviewed the right to access public records, defined a public records and the penalties.

# Regional Affordable Housing Initiative Report Presentation - Alberto Vargas, Manager, Planning Division and Mitchell Glasser, Manager, Housing and Community Development

- The Regional Affordable Housing Initiative investigated supply and demand
- Identified areas of opportunities, suitable for implementation for affordable housing
- Housing affordability is a major concern across most regions of the U.S.
- Housing affordability for whom:
  - o School teacher
  - o Restaurant server
  - School bus driver
  - o Retails person
- County lines; 90% stay within Orange County
- Regional population is growing very quickly, fairly consistent with Orange County growth. By 2040, we will have over 3 million residents.
- Good design determines success of affordable housing
- Purpose to increase housing options
- 30% of households are cost burdened
- 50% of households are severely cost burdened
- 110,000 households in Orange County are cost burdened
- Orange County's average home sale price is \$295,000
- Construction has been down across the nation
- Last year, there was an incredible growth in townhome developments in Orange County
- State Housing Initiative Partnership (SHIP) Allocation:
  - o Dedicated funding source for affordable housing
  - o Established Housing Trust Fund
  - o Administered by Orange County
  - Monitoring and oversight by the Florida Housing Finance Corporation
- FL Legislature swept the Sadowski Trust Fund (70% SHIP and 30% State Housing Trust Fund) for other priorities; legislature is allocating less money
- Implementation Framework:
  - Create increase the housing supply to meet the needs of all current and future residents
  - o Diversify encourage diversity of housing types and energy-efficient housing
  - Preserve preserve and protect existing and affordable housing stock
  - Integrate promote social and economic integration
  - Educate improve financial literacy and education of future homeowners and buyers
  - Reviewed the tools transformative, progressive and basic tools and their impact

#### Members of the Task Force:

- A member of the Task Force brought up a shipping container feasibility study that was conducted in 2016 and asked whether that would be included in Orange County's plan. Co-Chair suggested the subcommittee on Design and Infrastructure take a look at this as an option.
- A member of the Task Force asked if the meeting minutes can be published in Spanish. Mayor Demings said that could be done.

#### **Closing Comments:**

Terry Prather, Co-Chair said to stay focused on innovation and collaboration; the real work starts on the subcommittee level. Allan Keen and Terry Prater, Co-Chairs, thanked the Task Force members for their service and participation.
