PROJECT HISTORY


Orange County is in the process of right-of-way acquisition and updating construction plans for All American Boulevard from Clarcona-Ocoee Road to Kennedy Boulevard, a distance of approximately one mile. Design was completed in March of 2011, but was not funded for right-of-way acquisition or construction. The new roadway will serve to alleviate congestion. The new roadway will create a new railroad crossing at the intersection of Edgewater Drive and the proposed All American Boulevard. Construction is set to begin in Summer of 2024 or thereafter.


