**Summary of proposed ordinance (F.S. § 125.66(3)(a)1.):**

The proposed ordinance will amend Article V. Noise Pollution Control, Chapter 15 of the Orange County Code of Ordinances, known as the “Noise Control Ordinance of Orange County, Florida” (the “Noise Control Ordinance”). The proposed ordinance was prepared in response to the request of the Orange County Board of County Commissioners for revision of the Noise Control Ordinance. The purpose of the Noise Control Ordinance is to protect the health, safety, and general welfare of people of the county by preventing, prohibiting, and providing for the abatement of excessive and unnecessary noise, known as noise disturbances. Data collected from a Noise Ordinance Study that included a comparative analysis of noise ordinances in similar Florida communities was utilized to develop new noise level standards that are more compatible with similar Florida communities. To enhance the Orange County Sheriff’s Office’s enforcement efforts against noise disturbances, the proposed ordinance includes reduction of the Plainly Audible Standard Distance Sound Limits and other updates to the plainly audible standards. The proposed ordinance includes new and revised definitions that define the following terms: *distance measuring device*, *special events*, *unamplified voice*, *vehicles*, *emergency work*, *plainly audible*, and *noise disturbance*. In addition, certain exemptions were modified to further protect the health, safety and general welfare of the public. The time period for the noise ordinance exemption related to lawn maintenance activities was reduced from ending at 10pm to ending at 9pm; and the time period for the exemption related to construction and demolition activities was similarly reduced from ending at 10pm to ending at 9pm.
