- No swimming, pets, or alcohol.
- Please be respectful of group campers.
- No motorized vessels of any type or golf carts.
- No Styrofoam, glass items, fireworks, loitering or littering.
- Camp Joy does not offer any type of shuttle service.
- Canoe/kayak launch only; no BBQ's, fires, or tying to the trees.
- Camp Joy is not responsible for any lost or stolen property.
- Canoes or kayaks will not be launched during severe weather conditions.
- Guests may not harass or feed any wild life at any time; beware of alligators.
- Gate must remain locked and pass must be displayed in car dashboard at all times.
- All children under the age of six must wear a personal flotation device at all times.
- Launching hours are between 8am and 12pm; Guests must return no later than 5p.m.
- **Park in allotted parking area only; canoes/kayaks must be walked down to the waterfront.**
- **No inflatable inner tubes, rafts or similar flotation devices.** Inflatable kayaks or boats that are USCG approved are permitted after staff inspection.
- Violation of rules will result in expulsion.

## HOLD HARMLESS / INSURANCE AGREEMENT

I certify by signing this application that the above is true and correct. I understand that the event can be terminated by the County should it create or cause violation of any County Ordinance or Division Regulation. I certify that I am authorized by the sponsoring organization to act on their behalf in the signing of all documents associated with this event. I, and the sponsoring organization agree that we jointly and severally indemnify and hold Orange County and the Orange County Sheriff's Office harmless against all claims, damages, loss, and expenses, including court costs and attorney fees, resulting from the occupancy of the Park by the User, its agents, servants, invitees, and guests under this license.

The User will take all reasonable precautions for the safety of, and will provide reasonable protection to prevent damage, injury, or loss to all persons and property in the Park. The User will comply with all laws, ordinances, regulations, or other orders regarding the safety of persons or property, or their protection from damage, injury, or loss.

I have inspected the Park and it meets all event requirements. I will be responsible for securing any and all applicable licenses or permits. Entertainers, performers and exhibitors will comply with applicable copyright and licensing requirements and public decency codes.

The Facility Use Application details the Security/Damage deposit and reasons for possible forfeiture up to/including any deviation from contracted details. Security/Damage deposit may be forfeited if use of the Park exceeds the contracted details or requires inordinate attention to repair or clean the facility. Another Security/Damage deposit will be required as surety before a multi-day event may continue.

The applicant shall supply, when required, a Certificate of Insurance reflecting minimum coverage of \$1,000,000 Comprehensive, General Liability Insurance, without deductibles, per occurrence. Orange County shall be named as an "additional insured" which shall be noted on the Certificate of Insurance. The certificate shall indicate that the applicant's insurance policy shall not be cancelable without thirty days prior written notice to the County. Food sales or service which includes cooking or preparation of perishable items will require additional insurance.

The undersigned agrees to abide by the regulations governing the said facility and is responsible for charges incurred and must supply the Certificate of Insurance to the Orange County Parks and Recreation Division no later than fourteen (14) business days prior to the Program/Event date.
