Steps to Launching a Business in Orange County

1. Research & Plan

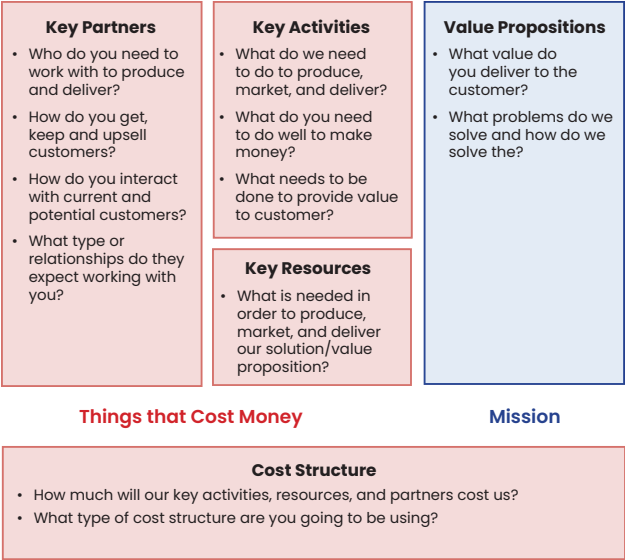
It is important to research and understand the market you will be entering. Take the time to ensure your idea is viable while preparing your startup endeavor.

Once the research is done, the next step is a plan of action. A well-thought-out plan should outline your strategy, target market, financial projections and provide a clear roadmap for goals. The plan will be necessary to obtain loans and funding.

There's no right or wrong way to write a business plan. What's important is that your plan meets your needs. Most business plans fall into two common categories: traditional or lean startup. Traditional business plans are more common, use a standard structure, and encourage you to go into detail in each section. They tend to require more work upfront and can be dozens of pages long.

Lean startup business plans are less common but still use a standard structure. They focus on summarizing only the most important points of the key elements of your plan. They can take as little as one hour to make and are typically only one page.

2. Create your B.A.I.L. team

OK, you trust your idea and have a plan. Now it's time to start putting together your team of professionals. To remember what you need, use the acronym B.A.I.L. Banker, Accountant, Insurance Agent, Lawyer/ Attorney.

A trusted B.A.I.L. team can help you avoid stumbling blocks while starting and growing your business.

3. Find your location

A successful business often starts with a good location. But selecting the perfect spot for your business is more than just finding a property or building you like. You also must know how to navigate local zoning requirements.

4. Determine your Legal Business Structure

One of the first decisions that you will make as a business owner is how the business will be legally structured. All businesses must adopt some legal configuration that defines the rights and liabilities of participants in the business's ownership, control, personal liability, life span, and financial structure. This decision will have long-term implications, so it is recommended you consult an accountant and attorney to help you select the form of ownership that is right for you.

5. Register your Business and Get a Business License

You must be registered on **SunBiz.org** to operate legally in the state of Florida. Please note that if you operate your business under a fictitious name or a DBA (Doing Business As) you may be required to register the fictitious name.

All businesses in Orange County must obtain their Business Tax Receipt (BTR) from the Orange County Tax Collector's Office. However, the review process depends on which jurisdiction it's located in.

If it's located in unincorporated Orange County

1. Submit a Zoning Approval Form to the Orange County Zoning Division.
2. Complete Orange County permitting review process.
3. Once approved, take Approval Letter to the Orange County Tax Collector's Office to receive your BTR.

If it's located in another municipality (e.g., City of Orlando or Apopka)

4. Submit an approval application to the City.
5. Complete City review process.
6. Once approved by the City, go to the Orange County Tax Collector's Office to receive your BTR.

6. Consider Insurance Options

There are several types of insurance that should be considered or could be required:

- **Business / Property**– Protects you financially against a variety of losses to your business and property.
- **Life / Health / Casualty**– Available to you and team members for personal use.
- **Workers Compensation**– Required by some businesses.

Choose an experienced Insurance Company and Agent who:

- You are comfortable with.
- Is from a financially-sound company of high ratings.
- Protects you against risks to your company's property.
- Communicates on updating your coverage when changing needs occur.

The next section of this guide will go over how to navigate Orange County's approval and permitting process.

Create Online Account

Orange County uses an online system called Fast Track for permitting and development applications. To get started, register to create an account using the 'Zoning/BZA' category. You will receive a temporary password via email. Once you login and change this password, you are ready to use Fast Track and submit the applications for your new business.

Scan the QR code and register for Fast Track.



Apply for Zoning Approval

Download and complete a Business Tax Receipt Zoning Approval Form and apply for a Business Tax Receipt permit on Fast Track. Upload the completed form as part of the online permit application and pay the non-refundable fee. The Business Tax Receipt is issued by the Orange County Tax Collector. Please visit the Business Tax Receipt webpage for more information.

Application Review

Orange County's Zoning Division will review your application to ensure that the new business is appropriate for the zoning district. A building permit is required to make alterations to existing buildings while a use permit is required for existing buildings with no alterations. Home-based businesses without alterations do not require a building permit.

Associated Building and Fire Permits

Most projects require fire permits and inspections.

New construction: apply for a building permit and complete all inspections.

Existing structures without alterations or change of occupancy: a Use Permit will be created in Fast Track. Login and complete the required permit information.

Existing structures with changes: apply for an alteration permit and complete all inspections.



Complete Inspections, Pay Fees

Use Fast Track to schedule your inspections and pay for any additional fees. Use Fast Track to view your building inspector's progress on the way to your site and review the results of your inspections. Visit the Fast Track Video Resources page for more information.

Impact Fees: Impact fees are charges assessed on new development to help pay for public infrastructure required to accommodate the new development. Impact fees are generally charged at the issuance of a project's building permit. Orange County collects Impact Fees for schools, law enforcement, fire, parks and transportation, as well as water and sewer capital charges.

Certificate of Occupancy

After final inspection, release of all holds, and payment of fees (additional impact fees may be due for a change of use), you will receive your 'C.O.' For a copy of the Certificate of Occupancy, please email buildingrecords@ocfl.net.

Contact The Business Tax Office

Contact the Business Tax Department to obtain your business tax receipt. Once this has been issued, you will be all set to open the doors to your new Orange County business.

Doing Business with Orange County

Step 3 AWARD Follow public openings, recommendations and awards using vendor services online.

Avoiding Code Violations

It's important to maintain your property to avoid a code violation.

What if I get a code violation?

There are a few ways for a business owner to get more information about a code violation at the property and initiate the process to resolve it.

- Contact the code inspector who issued the violation (their contact information will be on the code violation notice).
- Contact the Neighborhood Services Division (**407-836-4200**) and ask to be connected to the code inspector for the case.
- Contact 311 and ask to be connected to the code inspector for the case.

Tangible Personal Property

Businesses that own equipment used for business operations (e.g., furniture, machinery, computers, or other assets) will have TPP tax return filing requirements.

Please visit the property appraiser's website using the QR code below and select TPP Tax Return > General Information. There you will find details on filing requirements, deadlines, and more.
