Lt. Kelly Burda shared that there is still an uptick in car burglaries.

Executive Director Johnson asked if the speed radars could be placed at certain spots along Silver Star and Pine Hills Road.

She also asked about the students from Evans and the issue of crossing the street correctly. Lt. Burda mentioned that in theory the sheriff's office has done what they can to address the illegal crossing. There should be more of a sheriff's office presence as the school year ends. Chair Michael Strayhorn requested ideas for designs that could make pedestrians more likely to use the crosswalks.
