All registration information should go to the Orange County Division of Building Safety. <u>Please do not give registration information to the Orange County Utilities Water Division.</u> The Orange County Utilities Water Division will not place a Backflow Tester's name on its list of contractors until the Orange County Division of Building Safety registers him/her.

- Annual administrative recording fee of \$22 (Payable via check to: Orange County Division of Building Safety) (Due every year by September 30<sup>th</sup>)

The Orange County Utilities Water Division is tracking backflow assemblies for <u>containment only (at the water meter or property line) to include residential irrigation</u>, which may be on the side of the <u>building</u>.

# VOLUNTARY CODE OF CONDUCT FOR BACKFLOW PREVENTION ASSEMBLY TESTERS REGISTERED WITH ORANGE COUNTY DIVISION OF BUILDING SAFETY

- A Backflow Tester must have <u>up to date gauge calibration certificate</u> and a non-expired backflow tester training certification and registered with Orange County Division of Building Safety to be listed by; Orange County Utilities customer notification letters.
- A Backflow Tester must not knowingly falsify the results of any backflow assembly tests as described below.

#### **EXAMPLES:**

- A. Signing backflow test reports for tests they did not perform.
- B. Making unneeded repairs, failing a backflow assembly to just obtain new business work.
- C. Not having proper backflow certification to perform tests in Orange County.
- D. Not using proper test procedures.
- E. Using unauthorized backflow, non-calibrated test kit equipment.
- F. Falsifying records or reports.
- G. Not taking reasonable precautions to prevent backflow.
- H. Not obtaining proper permits.
- A Tester <u>must not</u> remove, replace or relocate a backflow device without the approval of the water purveyor (Orange County Utilities 407-836-6970).
- 4. Notify the water purveyor (Orange County Utilities 407-836-6970) if a new replacement assembly is installed with the water meter number associated with it and the old assembly serial number.
- 5. All backflow assembly test reports must be submitted to the water purveyor within 10 days of the initial test, no matter what the result. If there is a specific problem relating to the test or the test report form, the Tester must call the water purveyor Orange County Utilities at 407-836-6970 or 407-836-6873.
- All backflow test reports must be legible and contain all appropriate information pertaining to the test and can be emailed to <u>Water.Backflow@ocfl.net</u>, faxed to:(Orange County Utilities 407-836-6830) or mailed to: Orange County Utilities, Water Division, 8100 Presidents Dr., Orlando, FI 32809.
- 7. A Tester must renew their backflow Tester certification every two years and pay the annual backflow tester registration fee (\$22.00) to: Orange County Contractor Licensing Section. 201 South Rosalind Ave, Orlando, Fl. 32801, First floor.
- 8. It is the Tester's responsibility to inform Orange County licensing of any changes in their address, phone numbers, etc. You can call: 407-836-5522, or email: Contractorlicensing@ocfl.net. Any Backflow Tester failing to comply with the provisions of this Voluntary Code of Conduct is subject to removal of the Backflow Testers listing by Orange County Utilities. The results of the action can be the loss of listing privileges. By signing this sheet, I will to the best of my ability comply with the Voluntary Code of Conduct and be subject to terms listed above 1-8.
