

Message from the Director

The release of the Orange County Head Start Annual Report for 2018-2019 provides a perfect opportunity to look back at our many accomplishments. The annual report represents a partnership between Mayor Jerry L. Demings, Orange County Board of County Commissioners, Executive Director, Lonnie C. Bell, Jr., Policy Council and the numerous committed employees that show up daily to impact our community and change lives. I am proud of the outcomes highlighted in the report. It is evidence that the goals implemented garnered great results for child and family outcomes.

Orange County Head Start (OCHS) provides high quality, comprehensive, early childhood development services for 1,536 preschool children from economically challenged families in Orange County. Orange County is one of the fastest growing counties within Florida, with over 1,500 people weekly relocating to the area. Annually, over 1,700 children and over 1,600 families are served by Orange County Head Start with services delivered in 22 sites located throughout Orange County in 82 classrooms. These Head Start sites are co-located on Orange County Public School campuses, city municipalities, faith based organizations and stand-alone county operated facilities.

OCHS has served the community for over 50 years under the same grantee; Orange County Board of County Commissioners, which is made up of six elected officials, and a Mayor. There are no delegate agencies. The Head Start non-federal entity, Mayor Jerry L. Demings and Orange County Board of County Commissioners, are fully committed to improve school readiness outcomes and assist the families towards economic self-sufficiency.

Below I have highlighted a few program achievements the program garnered as a result of the implementation of the program goals:

- Opened one new Head Start site at Hungerford Elementary.
- Completed a five year ADA playground project.
- Held its first graduation of the six week session 24/7 Dad program, a total of 44 fathers graduated.



- Recognized in partnership with the Orlando Science Center as the 2019 Walt Disney World \$100,000 grant recipient.
- Awarded \$20,000 donation from Smart City and leveraged the funds to ensure all 1,536 children participated in the customized STEM field trips to the Orlando Science Center.
- Awarded the Edward Zigler, Aubrey Puckett, Ron Herndon Scholarship, Head Start Staff Scholarship, Parent of the Year and Corporate awards from the Region IV Head Start Association
- Utilized COLA funds and added needed positions; 1 Registered Nurse, 1 Maintenance Technician, 1 Family Services Worker (ERSEA) and 1 Maintenance Supervisor.

Everyday being present with the staff of Orange County Head Start reminds me that we're all in this work for the long haul. Momentum may not always be on our side, but the stakes are too high and the issues are too important to not keep moving forward.

I am more confident now than ever that Orange County Head Start and our many partners are well prepared to grow and evolve as one of the premier Early Childhood Educational institutions in Central Florida.

Explanation Of Budgetary Expenditures And Proposed Budget For FY 2018-2019

The proposed budget for FY 18-19 was \$18,387,245. Funds received were used to provide full-year, full-day comprehensive early childhood development services for 1,536 children and support to their families. Total expenditures of federal and non-federal funds

for FY 18-19 were \$17,527,643. All federal funds were used to cover salaries, cost of living increases, operation of services and training. The non-federal match (in-kind) was used to assist with salaries and operational expenses.

Efforts to Prepare Children for Kindergarten

Orange County Head Start utilizes the High-Scope Curriculum which promotes research-based teaching practices to support children’s development and learning in all Head Start Early Learning Outcomes Framework (ELOF) domains. The program uses the Galileo Pre-K assessment tool, G3 Assessment Scales, to evaluate children’s developmental progress. Teachers complete baseline assessments for each child and regular, ongoing observation and documentation of progress using the structured assessments provided.

A new area of focus for this school year was to enhance the access and use of technology in the classroom. Teachers assessed the children’s knowledge on technology and their ability to use technology. For example, children were observed to determine whether they can point/identify different components of a computer or laptop when asked by an adult (i.e. the screen, mouse, keyboard, etc.). By the end of the school year, children showed significant gains in their knowledge and use of technology and exceeded the predicted developmental learning level by three points.

The program also focused more closely on children identified as dual language learners to better support their development in English language acquisition and their continued development of their home language. The children who were identified as dual language learners were taught in three main areas: comprehending spoken English, speaking English and participating in literature in English. To ensure the learning environment was developmentally appropriate for dual language learners, the classrooms were filled with multi-lingual materials such as books, pens, puzzles, and rugs and equipment was labeled to represent the children’s home language. As a result of the efforts put forth by the program and teaching staff, the children who were dual language learners made significant progress in relation to their starting point and, as indicated in the chart, were only a few points short of meeting the predicted developmental learning levels by the end of the school year.

At the end of the 2018-2019 school year, a total of 903 children transitioned to kindergarten.

Child Assessment data reflected in the chart below shows that all these children made significant progress throughout the year and by the end of the school year, were well above the predicted developmental learning levels in the majority of developmental areas. Overall, the outcomes prove that curriculum and strategies implemented by Orange County Head Start are effectively working to ensure that children are well prepared academically, socially and emotionally for kindergarten.

Parent Involvement Activities

Parenting Curriculums offered by OCHS included the following:

For Me, For You, For Later is a 4 week financial literacy program designed by PNC Bank and Sesame Street for 3 to 5 year olds, as well as their families. Our parents benefit from the program by becoming more aware of their finances and learning how to talk to their children about how to manage money and make good choices. This is the third year the program has been offered to families and there have been significant gains in the number of families that participated. During the 2018-19 school year we had 135 participants compared to 102 participants the previous year, which demonstrated approximately a 32% increase in participation for this program.


CFPB's Financial Program is designed to enhance financial capability by educating and empowering our parents to address their financial decision regarding, opportunity and challenges that arise throughout their financial life cycle. OCHS utilizes this program to offer information and tools to address money management and other money topics through their family needs assessment. It also assists with preparing the next generation for financial success by developing money management habits and skills for the youth. During the 2018-19 school years 68 families participated.

24/7 Dad is a unique program designed to equip fathers with the self-awareness, compassion and a sense of responsibility that every good parent needs. It focuses on building the man first; father second, better skills in caring for children and building relationships with the mother of their children. OCHS philosophy behind the 24/7 Dads program is to support the growth and development of fathers and children as caring and compassionate people who treat themselves, others, and the environment with respect and dignity. During the 2018-19 school year 44 dad's participated.

Getting Ahead in a Just-Getting-By World is a 16 session research-based parent curriculum that helps low-income individuals to build resources for a more prosperous life for themselves, their families and communities. A total of 21 OCHS parents graduated during 2018-19.
